_____ Four Paws Bed 'n Biscuit Inn reserves the right to immediately change your pet's type of boarding/daycare if we believe it is necessary to protect the health and well-being of your pet(s), other pet(s), or our staff.

_____ All pet(s) must be healthy and current on all vaccinations. You will be required to bring a copy of your pet(s) updated vaccination records from your vet before you start daycare or board with us to ensure your pet(s) safety as well as that of our existing Four Paws Bed 'n Biscuit Inn pet(s). Owner specifically represents to Four Paws Bed 'n Biscuit Inn that the pet has not been exposed to any communicable diseases within a thirty-day period prior to boarding.

_____ If your pet(s) is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please do not bring your pet(s) to daycare or boarding. These pets should stay with your vet.

_____ I acknowledge and understand that there are certain risks involved in day care and boarding, including but not limited to pet(s) fights, pet(s) bites to humans or other pet(s), and the transmission of disease. Any medical expenses will be my responsibility and I release Four Paws Bed 'n Biscuit Inn of any charges.

_____ The house brand of food may be different that your pet(s)'s current diet. Changing a pet's food can cause an upset stomach, owners are welcomed & encouraged to bring their pet's food from home. Owners are welcome to bring their pet's own bedding or toys if desired, however we cannot guarantee that they will be returned in the same condition.

_____ We accept Visa credit cards, cash, or check (\$30 returned check fee). Payment is due upon pickup of your pet(s). Four Paws Bed 'n Biscuit Inn reserves the right, without notice, to adjust its fees for services. Please inquire at the front desk as to our current fees.
